### What data do we collect?

### How do we collect your data?

**How do we store your data?**

Little Crow Marketing will keep your data indefinitely until you request that we remove it as this allows us to keep you informed of all relevant activities.

You have the right at any time to stop Little Crow Marketing from contacting you for marketing purposes.

**What are your data protection rights?**

Little Crow Marketing would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

**The right to access** – You have the right to request Little Crow Marketing for copies of your personal data. We may charge you a small fee for this service.

**The right to rectification** – You have the right to request that Little Crow Marketing correct any information you believe is inaccurate. You also have the right to request Little Crow Marketing to complete the information you believe is incomplete.

**The right to erasure** – You have the right to request that Little Crow Marketing erase your personal data, under certain conditions.

**The right to restrict processing** – You have the right to request that Little Crow Marketing restrict the processing of your personal data, under certain conditions.

**The right to object to processing** – You have the right to object to Little Crow Marketing's processing of your personal data, under certain conditions.

**The right to data portability** – You have the right to request that Little Crow Marketing transfer the data that we have collected to another organisation, or directly to you, under certain conditions.
